

INFORMATION ON THE PERSONAL DATA PROCESSING
(ARTS. 13 and 14 REG. EU 2016/679)

the EU Regulation no. 2016/679 relating to the protection of individuals with regard to the processing
of personal data, I have to inform you that the processing of personal data acquired and supplied by
ASSOCIAZIONE SIAF ITALIA, will be processed in accordance with the regulations provided for
by the abovementioned Regulation in accordance with the consequent rights and obligations:

- a) **PURPOSE OF THE PROCESSING** – The treatment is processed solely for the purposes of correct and complete fulfilment of the assignment received by ASSOCIAZIONE SIAF ITALIA.
- b) **PROCESSING OF PERSONAL DATA:** The treatment is implemented through transactions with or without the assistance of electronic devices; it consists of the collection, registration, organization, conservation, consultation, processing, modification, selection, extraction, comparison, use, interconnection, block, communication, dissemination and destruction of data. The processing is carried out by the Data Controller and by the processors expressly authorized by the holder.
- c) **CONFERRAL OF DATA AND REFUSAL:** The provision of personal, sensitive and judicial data is necessary for the conduct of activities referred to in paragraph a) and the refusal by the individual to give personal information makes it impossible to accomplish the activities referred to in paragraph a).
- d) **DATA COMMUNICATION** - Personal information may be disclosed to those responsible for treatment and may be disclosed for the purposes referred to in paragraph a) to external partners and, in general, to all those persons to whom the disclosure is necessary to achieve the purposes described in section a).
- e) **TRANSFER OF DATA ABROAD** - Personal data may be transferred to European Union countries or to third countries with respect to those of the European Union or to an international organization, within the scope of the purposes of point a). The interested party will be informed whether or not there is a decision on the adequacy of the EU Commission.
- f) **DATA RETENTION** - The data shall be kept for the period necessary to carry out the activity and in any case not more than ten years.

h) RIGHTS OF THE DATA SUBJECT - The person concerned is entitled:

- to access, rectification, cancellation, limitation and opposition to the processing of data;
- to obtain the data in a structured format of common use and readable by an automatic device to transmit it to another data controller without hindrance from the data controller;
- to withdraw the consent to the processing, without prejudice to the lawfulness of the processing based on the consent acquired before the revocation;
- to file a complaint to the Authority for the Protection of Personal Data.
